<b>Docket Entry:</b>	97-11070897 UPON CONSIDERATION OF PETITIONER-PLAINTIFF'S PETITION FOR INJUNCTIVE RELIEF, DEFENDANTS RESPONSE THERETO AND AFTER HOLDING A PRELIMINARY INJUNCTION HEARING, THIS COURT MAKES THE FOLLOWING FINDINGS: (A) THE RIGHT OF PETITIONER-PLAINTIFF TO THE REQUESTED RELIEF IS CLEAR AND IRREPARABLE HARM AND LOSS WILL RESULT IF A PRELIMINARY INJUNCTION IS NOT GRANTED FORTHWITH. (B) PETITIONER-PLAINTIFF DOES NOT HAVE AN ADEQUATE REMEDY AT LAW AND (C) GREATER INJURY WILL BE INFLICTED UPON PETITIONER-PLAINTIFF BY THE DENIAL OF A PRELIMINARY INJUNCTION THAN THE INJURY TO DEFENDANT BY GRANTING A PRELIMINARY INJUNCTION. ACCORDINGLY IT IS HEREBY ORDERED AND DECREED THAT PETITIONER-PLAINTIFF REQUEST FOR A PRELIMINARY INJUNCTION IS GRANTED AND (1) DEFENDANT ROBERT F. ENGLERT ESQUIRE SHALL COMPLY WITH ALL PROVISIONS OF HIS EMPLOYMENT AGREEMENT DATED MAY 3, 2006, AND THE MODIFICATION THERETO DATED SEPTEMBER 12, 2009; (2) DEFENDANT ROBERT F. ENGLERT ESQUIRE IS PROHIBITED FROM AFFILIATING WITH A LAW FIRM, OR OBTAINING EMPLOYMENT OTHER THAN WITH KLINE & SPECTER PC EXCEPT AS IS PERMITTED UNDER THE EMPLOYMENT AGREEMENT; (3) DEFENDANT ROBERT F. ENGLERT IS PROHIBITED FROM SOLICITING CLIENTS OF KLINE & SPECTER PC. THIS ORDER SHALL REMAIN IN FULL FORCE AND EFFECT UNTIL SEPTEMBER 5, 2011, OR UNTIL SUCH TIME AS THIS COURT SPECIFICALLY ORDERS OTHERWISE. PREVIOUS BOND SHALL REMAIN IN EFFECT.
