**IRVINE, CA (June 24, 2015)** - The Irvine Chamber of Commerce today named national labor and employment law firm Fisher Phillips as the "Business of the Year" award recipient for 2015. The award was presented by Irvine Chamber President and CEO Tallia Hart and Irvine Mayor Steven S. Choi, Ph.D., during Irvine's annual Business Luncheon and State of the City address in front of an audience of more than 375 members of Orange County's business community.
