his J.D. from the University of Southern California, Gould School of Law (2009) and his B.A., *summa cum laude*, from the University of Southern California (2005).

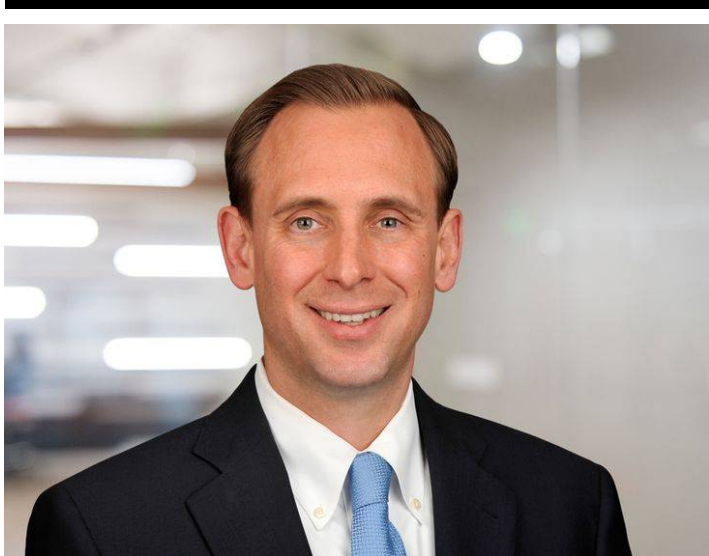

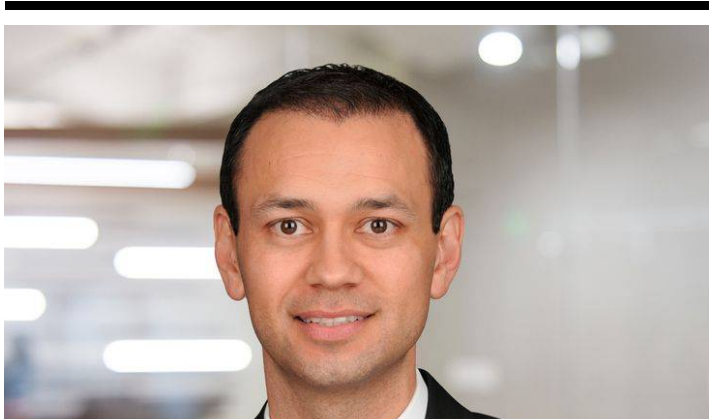
