For the seventh consecutive year, Fisher Phillips Chairman and Managing Partner Roger Quillen has been selected to "The Top 100 Most Powerful Employment Attorneys" in the United States by *Human Resource Executive* magazine.

Quillen joined Fisher Phillips in 1980 and has served on the firm's management committee since 1997. He has been the firm's chairman and managing partner since 1999. Quillen is effectively the CEO of an organization with 350 attorneys and an additional support staff of more than 300 people. His practice involves litigation covering a wide range of employment discrimination issues, employee welfare benefit plans, the Railway Labor Act and issues arising before the National Labor Relations Board and the Equal Employment Opportunity Commission. His special emphasis is in federal appellate litigation.
