9TH CIRCUIT GIVES EMPLOYERS MORE FLEXIBILITY TO FIGHT 'DAY-OF-REST' CLAIMS

In August, the U.S. Court of Appeals for the 9th Circuit affirmed a lower court ruling dismissing "day of rest" claims brought by two former Nordstrom employees.
