Overview

Along with her litigation work, Christine counsels clients regarding appropriate handling of disciplinary matters, employee terminations, internal investigations, the development of preventive policies and procedures, compliance with state and federal laws relating to wages, leaves of

absences, harassment and discrimination. In addition, she regularly conducts compliance and management training and frequently lectures on employment issues for trade groups and associations as well as private employers.

In addition to employment litigation, Christine represents commercial property owners and property management companies in the defense of housing discrimination claims under the Fair Employment and Housing Act (FEHA), the Unruh Act, and the federal Fair Housing Act as well as disability discrimination claims under Title III of the Americans with Disabilities Act (ADA).
