Most recently Jason was in-house at a leading video game holding company where he served as employment counsel for the company's diverse studios and operations globally. In this role, he counseled and advised management on all employment and labor topics with a focus on litigation, risk management, policy creation, training, and implementation of best practices.

Jason now returns to Fisher Phillips where he will represent employers in state and federal courts and counsel them on compliance with a vast array of employment-related laws and regulations. A large part of his practice will focus on representing companies in a variety of workplace disputes ranging from single-party harassment and discrimination claims to large wage and hour class action and California PAGA matters.
