#### Overview

advice and counsel for activities funded by an \$81M annual budget. Prior to TCAD, Marcia held an executive service position with the Tennessee Department of Human Services (DHS). As Assistant Commissioner of the second largest state department, Marcia managed the agency's Public Information and Legislative Office, including testifying before the Tennessee General Assembly, managing all external and internal communications for the department, and serving on the Executive Leadership Team.

Marcia previously spent 12 years as a partner in the Nashville office of a national law firm handling a wide array of management-side employment matters for executives, small business owners, local manufacturers, distributors, healthcare facilities, and Fortune 500 companies.
