Overview

Adam Sloustcher is Co-Chair of the firm's Sports Team, a diverse group of former collegiate and professional athletes dedicated to advising sports employers regarding compliance with applicable laws and regulations and managing controversies, as well as vigorously defending them before governmental, regulatory, and administrative agencies and, when necessary, in litigation.

Adam Sloustcher represents local, regional and national employers in a broad range of employment disputes. He specializes in defending employers in wage-and-hour class action lawsuits, as well as those brought under California's Private Attorneys General Act (PAGA). Adam also has extensive experience litigating equal pay class actions and single-plaintiff discrimination, harassment, retaliation, and wrongful termination lawsuits.

In addition to zealously advocating for his clients in the courtroom, Adam prides himself on being an accessible, responsive resource to help his clients avoid litigation altogether. He acts as a partner to in-house counsel, business owners, and management by providing them with day-to-day preventative advice regarding wage-and-hour compliance, investigations of alleged misconduct in the workplace, hiring, discipline and termination practices, leaves of absences, and the interactive process and reasonable accommodations. Adam's drive to achieve the best possible outcome for his clients stems from his competitive athletic background. Growing up, he was a member of the Under-17 and Under-18 U.S. Youth National Soccer teams and named a McDonald's and Parade All-American. Adam went on to accept a full athletic scholarship to the University of North Carolina-Chapel Hill, and would later transfer to Loyola Marymount University – where he became team captain of the university's NCAA Division I Men's Soccer Team. Adam then played professional soccer with the San Jose Earthquakes of Major League Soccer.

After obtaining damaging admissions during plaintiff's deposition and then filing a motion for summary judgment, Adam was able to force plaintiff to voluntarily dismiss his lawsuit in exchange for a waiver of costs.
