Overview

Cathy Stutin is a partner in the firm's Fort Lauderdale office where she focuses on helping employers navigate employment claims to successful resolutions and dismissals. A significant portion of Cathy's practice is also devoted to counseling employers on the preventive measures they may take to avoid or reduce employment-related claims, including supervisory training and the development and administration of effective human resources policies and practices.

She is the author of Comment, *Arbitration and Selective Discipline of Union Officials After Metropolitan Edison*, 44 U. Miami L. Rev. 443 (1989), and was selected by the National Association of Women Lawyers to receive the Outstanding Woman Law Student Award at the University of Miami.
