#### Overview

Sara Myirski advises and represents businesses in various workplace law matters, with a particular focus on handling disputes involving the movement of employees between competitor firms. In addition to her work on employee transition matters, Sara advises clients on general employment issues, such as wage and hour, discrimination, harassment, hostile work environment, and wrongful discharge. Sara can also assist employers with drafting and updating policies and handbooks, FLSA exempt/non-exempt classification, ADA reasonable accommodations, independent contractor status, and restrictive covenant agreements.
