Overview

Lauren also previously served as in-house counsel for a public community college in the Dallas/Fort Worth area. In this capacity, she provided strategic advice and legal counsel to the Chancellor, six campus presidents, the COO, and others including the Human Resources Department regarding

personnel issues, employment issues, and performance management. She also advised on internal investigations involving claims of alleged misconduct under Title IX; trained HR personnel in legal developments impacting faculty and staff across six campuses; and drafted policy regulations and process documents for the college.

Prior to her in-house roles, Lauren was in private practice at both a boutique labor and employment firm in Fort Worth and a regional corporate firm with various locations throughout Texas.
