The new office is on the eighth floor of the Financial Center building (505 20th Street North) in the heart of downtown Birmingham. Located near the Theatre District, the space is walkable to key Birmingham businesses as well as a variety of entertainment venues, restaurants, shopping, and attractions such as the Birmingham Civil Rights Museum and Birmingham Museum of Art. The office is also conveniently located near City Hall, the Hugo Black Federal Courthouse, the Jefferson County Courthouse, and is only a ten-minute drive to the Birmingham Shuttlesworth International Airport.


