Prior to that, she was counsel for a national real estate and economic development firm where she represented housing authorities, property managers, and municipalities in Fair Housing Act (FHA) litigation, civil rights disputes, and HUD compliance matters. Before returning to the private sector, Jill served for 12 years as a career law clerk in the United States Bankruptcy Court for the Northern District of New York. Drawing on her combined

private and public sector experience, Jill works closely with employers to understand their organizational objectives, minimize risk and business disruption, and prevent or resolve litigation while remaining ready to aggressively defend lawsuits when required.
