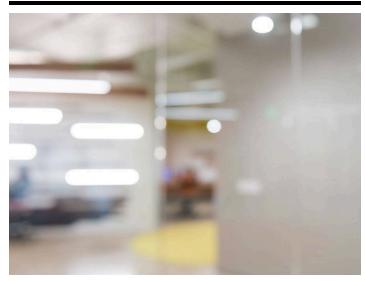
Josh received his J.D. from Michigan State University College of Law and his B.A. from the University of Nevada, Reno.
