Overview

Logan also spent five years as a management consultant, where he applied his multidisciplinary background to help businesses navigate issues at the nexus of law, commerce, and public policy. Logan has significant experience representing clients through high-stakes reputational and crisis management issues. Beyond the labor and employment realm, he has also advised clients through Congressional, U.S. federal agency, and state attorneys general investigations, international trade and customs matters, intellectual property and trade secrets disputes, product recalls, clinical trial errors, and environmental disasters. Notably, Logan served as the principal crisis communications consultant for Norfolk Southern in the aftermath of the East Palestine train derailment, having deployed to Ohio to act as the company's representative to media, regulators, and elected officials. In addition to his reactive crisis communications experience, he is also well-versed in developing proactive plans for organizations, to include preparing playbooks, media training spokespeople, and leading preparedness and table-top training exercises.

Throughout his career, Logan has represented clients across many industries, and is particularly familiar with the aerospace & defense, agricultural, energy, financial services, healthcare & life sciences, technology, and transportation sectors.
