From the North

From Lawrenceville, Duluth, Norcross and Chamblee areas:

Take I-85 South; take exit 84 (17th Street Exit) toward 14th Street/ 10th Street; take the ramp toward 14th Street/10th Street; Turn LEFT onto 14th Street and continue to follow 14th Street; turn RIGHT onto Peachtree Street; 1075 Peachtree Street is on the LEFT.

From Alpharetta and Roswell areas:

Travel south on GA 400 through the toll booth (\$.50 toll); continue south as this becomes I-85 South;

take exit 84 (17th Street Exit) toward 14th Street/ 10th Street; take the ram toward 14th Street/10th Street; Turn LEFT onto 14th Street and continue to follow 14th Street; turn RIGHT onto Peachtree Street; 1075 Peachtree Street is on the LEFT.

From Marietta, Smyrna and Cobb County areas:

Take I-75 South; take exit 250 toward 10th Street/14th Street/Georgia TECH; Stay straight off the exit to go to Williams Street NW; Turn RIGHT onto 10th Street NW; Turn LEFT onto Peachtree Street; 1075 Peachtree Street is on the RIGHT.

From the South

From Forrest Park, College Park, Riverdale, Airport and Hapeville areas:

Take I-85 North; take exit 250 toward 10th Street/14th Street/Georgia TECH; Stay straight off the exit and merge onto Williams Street NW; Turn RIGHT onto 10th Street NW; Turn LEFT onto Peachtree Street; 1075 Peachtree Street is on the RIGHT.

From the East

From Conyers, Lithonia and South DeKalb County areas:

Take I-20 West to Exit 57 and merge onto I-75 N/ I-85 N; take exit 250 toward 10th Street/14th Street/Georgia TECH; Stay straight off the exit and merge onto Williams Street NW; Turn RIGHT onto 10th Street NW; Turn LEFT onto Peachtree Street; 1075 Peachtree Street is on the RIGHT.

From the West

From Douglasville, Lithia Springs, Austell, Six Flags, Fulton Industrial and West Cobb areas:

Take I-20 East to I-75/85 North; take exit 250 toward 10th Street/14th Street/Georgia TECH; Stay straight off the exit and merge onto Williams Street NW; Turn RIGHT onto 10th Street NW; Turn LEFT onto Peachtree Street; 1075 Peachtree Street is on the RIGHT.
