Moreover, new supervisors or newly promoted supervisors must receive the required training within six months of hire or promotion. This training is mandatory for any supervisor who hires, fires, disciplines, and/or directs the work of one or more other employees. This dynamic workshop is a cost-effective way to provide this mandatory training to supervisors. The training is interactive and practical, teaching supervisors essential management skills while discussing the legally required harassment related topics.
