### Higher Education Compliance Bootcamp: Title IX and Beyond

The Independent Colleges and Universities of Florida is pleased to host a two-day Higher Education Compliance Bootcamp for higher education administrators on June 20 and 21 at Keiser University in Tampa, Florida.

This program will teach participants how to design a campus-wide compliance infrastructure that can be utilized to manage all compliance functions from Cabinet level to department level in a manner that reduces silos, increases effectiveness, and builds confidence in compliance efforts at all levels. Particular attention will be paid to Title IX and ADA compliance during this two-day session.

**Scott Schneider** heads the Higher Education Practice Group for Fisher Phillips and is a nationally recognized professional on higher education legal issues and institutional response to sex assault. Currently, Ms. Fink serves as chair of the Sexual and Gender-Based Misconduct Advisory Committee, on the Women's Advisory Board, and on the Gilda's Club of South Florida Young Leadership Council.
